PUBLIC PARTICIPATION

Mitchell Owens addressed the board regarding the tennis court project. The tennis court committee is working under the Bryan Athletic Boosters Club. Six new courts would be constructed on the Bryan City School District campus, to serve both students and the community. To date \$400,000 had been raised toward the \$550,000 project. These additional courts would provide:

- 1.) The ability for more students to participate in varsity tennis due to the current shortage of courts.
- 2.) More community access to tennis courts.
- 3.) Facilities that can be used for physical education classes.

Mr. Owens requested that the Board of Education provide \$75,000 toward the project. The board asked questions relating to the playing surface, long term maintenance, and lighting.
