Parent-Teacher Conferences were recently held and 98% of our parents attended. The Christmas for Kids program started and will run for a week. Mrs. Dominique is doing a Math Fact and Sight Words program with the students.

MS/HS report by Mr. Bassett: December 2 will be college and career day. Academic League is competing in its annual tournament this weekend. The MS/HS will do Christmas for Kids the week after Thanksgiving. Congratulations to Fall Play for a terrific performance.

Assistant Superintendent report by Mr. Bassett: Gifted Testing is complete. Results will be sent home in the near future. The district-wide safety drill will be held this week. The district is now providing meals to St. Patrick's school under the Seamless Summer program. In October we served just under 25,000 meals.

Teaching and Learning report by Mrs. Cox: The district is continuing to assess learning loss from COVID. In 1st grade we have been evaluating reading fluency. So far this year, we have increased fluency by 27%. Information went home to parents at parent-teacher conferences. The value-added data was released by the state. The district showed "more than expected growth" in most areas and "expected growth" in the rest of the areas. We are still awaiting the report from the Dyslexia Committee. The elementary social study committee met but has not made any decisions. The science committee meeting also met. A CPI refresher course was recently held. Our PBIS team met to document our progress to share with other districts. The high school is beginning to look at scheduling for next year.
